7. CONTROL OPERATIONS Upon receiving ARES/Everbridge Alert, check-in with "ARES NET Control" (Bob K6UDA) on the W6SAR Roseville repeater (146.640 –PL 156.7). Once receiving confirmation by NET Control, stay parked on that frequency. If you have to leave frequency (i.e., going to HF, etc.) please notify NET Control. Those stations arriving to check-in at the Rocklin HS gym (assigned Victory High Reunification Site), will need to notify NET Control of their location and switching frequency to the N6ICW repeater (147.195 +PL 123.0). Once on frequency, contact W6TOC (Marty) of your location. Contact the VHF NET Control to find out what HF frequency ARES is currently on.					
8. SPECIAL INSTRUCTIONS <u>Notify Resource NET Control immediately of changes in location, illness, or injury. If above repeaters fail, ARES NET Control will switch to PC ARES Tac 1 (simplex) 147.580 with a backup frequency of 145.580 (simplex – PC ARES Tac 2).</u> Announce "Break, Break" along with "Real World Emergency" when needed.
