Subject: FCC RM-11708 - Help keep the FCC from potentially destroying

the CW/Data portion of the HF bands.

It has come to my attention that some of you have not heard about the new FCC RM that is being considered. This proposal by the ARRL will allow the CW/Data areas of the HF bands to be used for 2.8 MHz wide full power unlimited baud rate data transmissions. Some of these transmissions will come from automated stations that do NOT listen for other CW, QRP transmissions before sending! This also means for example, that in the space of the 40 meter band only 35 of these transmissions would fill up the entire CW/Data portion of the band, while otherwise as many as 500 cw/data QSOs could be going on. This proposal also gives access to automated stations to send E-Mails over Ham Radio bands using Pactor/WinLink 3 and 4.

It is **VERY** important that you take 5 minutes to send a comment to the FCC to **OPPOSE** this proposal. If not we could potentially loose our CW/Data portions of the band. RM-11708 would allow wide-band automated digital transmissions to cause wide spread interference to efficient narrow-band digital modes including CW (A1) transmissions. The RM-11708 proposal is not needed as current VHF/UHF and other voice bands can provide ample spectrum for wide-band digital modes.

I strongly urge the commission to REJECT RM-11708.
